Before submitting an application, please read the following comments, notes and explanations. In past years, this page was incorporated into the application. As the need for such information increases, I am attempting to handle it separately. Keeping this information where it can be found will answer a lot of last minute questions which may come to mind.

**TRANSPORTATION:** Regardless of how it appears on the application, transportation is available from each pickup point for every session.....unless the enrollment does not justify the expense of placing a bus there. If the enrollment does not support placing a bus at your point, you will be allowed to bring them, organize a carpool, use any other transportation point or accept a full refund.

W. Paces and Riverside buses depart each morning at 8: 25 am and return to their same points at 3:00 pm. If you provide your Own transportation, you may arrive at 9:05 am and pickup at camp by 2:15 pm. Each afternoon, ***buses will wait for 12 minutes and if your child has not been retrieved in that period, they will return to camp where you may pick them up.***

**TUITION** includes all costs. If you provide your own transportation to camp, you are entitled to a \$25 transportation credit.

**LUNCH** is to be brought daily. Camp provides lunch beverages.

**ABSENCES:** If your child misses any portion of a camp session, tuition will not be refunded. Missed days cannot be made up at other sessions.

**BEE ALLERGIES:** Campers who knowingly require emergency room medical treatment in the event of a bee sting cannot be admitted to camp.

**SIBLING DISCOUNTS:** \$20.00 for each additional child in a family.

**REFUNDS:** By March 31, 2008, 100% refund. After March 31, 2008, no refund.
